THE QUALIFIED INDIVIDUALS LIVE IN THE HOUSINGS OWNED BY ORGANIZATION AND PAY 30% OF THEIR INCOME TOWARD RENT AND UTILITIES. IN 2016 THIS PROGRAM SERVED OVER 178 TENANTS.
