THE AFFORDABLE HOUSING PROGRAM BEGAN IN RESPONSE TO THE INCREASING COST OF RENTING DECENT, SAFE AND ACCESSIBLE HOUSING FOR PERSONS WITH DEVELOPMENTAL DISABILITIES. THE QUALIFIED INDIVIDUALS LIVE IN THE HOUSINGS OWNED BY ORGANIZATION AND PAY 30% OF THEIR INCOME TOWARD RENT AND UTILITIES. IN 2021 THIS PROGRAM SERVED 202 TENANTS. PARKVIEW SERVICES ALSO PROVIDES MAINTENANCE SERVICES TO AFFORDABLE HOUSING ORGANIZATIONS AND PREPURCHASE HOME REPAIRS TO QUALIFIED HOMEOWNERSHIP CLIENTS.

THE GROUP HOME PROGRAM WAS ORIGINALLY ESTABLISHED TO PROVIDE RESIDENTIAL SUPPORT SERVICES TO CHILDREN WITH DEVELOPMENTAL DISABILITIES. HOWEVER, THE ORGANIZATION HAS SHIFTED ITS SERVICE POPULATION TO ADULTS IN ORDER TO CONTINUE SERVING THE CHILDREN WHO WERE REACHING THEIR ADULT AGE AT THE ORGANIZATION. CURRENTLY, SIX ADULTS LIVE AT THE GROUP HOME AS CLIENTS. IN 2021 THIS PROGRAM PROVIDED OVER 15,592 HOURS OF DIRECT SUPPORT SERVICES TO THE RESIDENTS. THE ORGANIZATION ALSO PURSUED GOVERNMENT SUPPORT, INCLUDING CORONAVIRUS AID RELIEF AND ECONOMIC SECURITY (CARES) FUNDING, AND PAYCHECK PROTECTION PROGRAM AND ECONOMIC INJURY DISASTER LOANS, TO HELP COVER HAZARD PAY, KEEP CLIENTS IN THEIR HOMES, AND TO KEEP ALL PROGRAMS OPERATING.

HOMEOWNERSHIP PROGRAM OFFERS HOME BUYING ASSISTANCE IN KING, SNOHOMISH, WHATCOM, YAKIMA, SPOKANE, CLARK, AND SKAGIT COUNTIES TO PEOPLE WITH DISABILITIES AND FAMILY MEMBERS WHO WILL LIVE WITH THEM. THE ORGANIZATION ALSO WORKS WITH CURRENT HOMEOWNERS ANYWHERE IN THE STATE OF WASHINGTON THAT NEED HELP TO AVOID FORECLOSURE. IN 2021 THIS PROGRAM SERVED OVER 801 CLIENTS.
